## 175. Budget and Precept for 2023/24

The content of the Budget Proposal was discussed with reference to the recommendations made by the Resource Committee.

The budget for 2023/24 was agreed at £227k which was a shortfall of £27k. To bridge this gap it would need a Precept increase of 15% which would mean a 63p per month increase per household.

Balances at the start of 2022/23 General Reserve of £108,000 (GR) would close at year-end at £97,000, representing six months Net Revenue.

It was **resolved that** the increase of 15% be accepted.

#### 176. Governance Update

The Clerk updated members and informed them that the February Full Council Meeting would be focusing on Standing Orders, Finance regulations and Risk Assessments.

#### 177. Neighbourhood Plan Working Group

With the impending Local Plan due to be published by WBC in the next 12 months, The Neighbourhood Plan Working Party (NPWG) is to re-commence with members of the Parish Council, but in the main 'residents'. It was **resolved that** Several Councillors would support Cllr Chisholm in the re-igniting of the group (please find attached notes from Cllr S Chisholm). In the meantime, the Clerk will look to investigate possible grant opportunities to support the group. **CF/SC** 

#### 178. South Warrington Parishes Working Party

Cllr Taylor updated members following on from the Planning Inspectors report published in December 2022. SWP remains a united platform to gain strength for resisting and protecting the Green Belt in South Warrington.

After the examination in public September 2022, of which SWP was represented by John Groves and Piers Riley-Smith, the Planning Inspector has told WBC that the Local Plan is unsound.

Following on from the report, the Secretary of State has called in the Six56 application for a public inquiry, SWP will be attending as a Rule6 participant.

There will also be a public examination of the Local Plan and SWP will need funds to carry on their fight to protect the greenbelt.

Grappenhall and Thelwall will continue to support SWP for the foreseeable future.

## 179. Thelwall Local History Group

The Thelwall Local History group will be celebrating the 1100<sup>th</sup> anniversary of Thelwall being a 'Cyty' in 2023. Cllr L Fernyhough updated members at the Parish Council meeting. The next meeting is on the 25<sup>th</sup> of January and celebrations to mark the occasion are likely to be around mid-September.

#### 180. Green Flag Award Walled Garden

Due to the timeliness of the response required the Walled Garden team requested Councillors to consider applying for the status again.

In recent years this award has hitherto been free for the Community Award section. We have received an email from the Green Flag Award that this year they are looking for **a** payment of £369 to enter. It is a prestigious, internationally recognised accolade, which the Walled Garden has successfully been awarded for the last six years, but as there is now a cost implication, we need to consider it. It was **resolved that** the Walled Garden would apply for Green Flag status.
