Introduction

I have been fortunate to have lived in the heart of the historic and picturesque village of Grappenhall since July 2001.

I live with my wife; Sam and two children; Ella and Dan who have both attended St Wilfrid's Primary School before moving onto Lymm High School.

I was invited onto the Grappenhall & Thelwall Parish Council back in May 2007 and one of the many highlights during my tenure as Parish Councillor was to serve as Chairman during 2012/13.

Whilst devoting my time and energy to the wellbeing of our local residents and the local environment, my personal three key priorities are as follows.

1. Improving Road Safety

My primary focus has been on Church Lane during St Wilfrid's School opening and closing times together with the volume of speeding traffic coming down Broad Lane into the village.

With the support from St Wilfrid's Headteacher, much progress has been made through banners, parking buddies and parking dos and don'ts initiatives. However, still more is required to create a safer environment for school children.

The Parish Council has secured funding for traffic calming measures on Broad Lane from the Cricket Club down to the village which we hope to implement following a successful WBC 'consultation' with local residents.

2. Protecting Greenbelt

Protecting Greenbelt within the Parish is dear to my heart. As confirmed in the Village Design Statement; Section 6. Rural environment and recreation; both villages are surrounded by open countryside to the east and south and these rural parts of Grappenhall and Thelwall. Much of this good-quality farmland constitutes a working landscape. It both provides a livelihood for the local farming community and is a living reminder of much that enabled the villages to thrive in the past. It represents 80% of the total area in the Parish.

3. Reducing Air Pollution

Reducing air pollution and improving air quality is a huge challenge and one that I've been addressing in line with the Village Design Statement. One of its key themes is to 'reduce the impact of road traffic on residential areas and the Village Conservation Areas' when managing future development and change.

I've personally made a contribution in reducing air pollution by driving a Plug-In PHEV vehicle which I've been running mainly on battery power!

Other Key Issues

I'm working hard with the Parish Council to get some much needed and overdue certainty over the future of The Rectory and Grappenhall Hall School which have disappointingly gone from being the village's 'Jewels in the Crown' to 'Eyesores'. The Parish Council website features a monthly update on these and other key issues within our villages for our local residents to regularly review.

Village Design Statement

I've made reference to the Grappenhall and Thelwall Village Design Statement a couple of times. New development is both inevitable and necessary for a living countryside and Village Design Statements offer a way for local communities to help set the context for new development, so that it can be designed to fit its location and protect and enhance local character.

I'm a huge advocate of this document which is an excellent read and is available for local residents to review on our website.
